Federal Direct Parent Loan Request (PLUS) Information

The Federal Direct Parent Loan for Undergraduate Students (PLUS) is designed to assist the parents of dependent undergraduate students in meeting educational expenses. There are no income restrictions on eligibility for this loan; however, the student must use his/her own Federal Direct Student Loan eligibility before a Parent PLUS loan will be awarded and paid.

Eligibility: The parent borrower must be the biological or adoptive parent for the student for whom you are borrowing. If you are the step-parent of the student, you may borrow a Federal Direct PLUS loan only if your income and assets were reported on the Free Application for Federal Student Aid (FAFSA). A non-custodial biological parent may also borrow under the Federal Direct PLUS program; however, the custodial parent must file the FAFSA.

The parent must be a U.S. citizen or national, permanent resident of the United States, or an otherwise eligible non-citizen. The parent must not be in default on a federal education loan or owe an overpayment on a federal education grant. The student must be dependent and enrolled or accepted for half time enrollment at Carl Albert State College.

Disbursements: Federal Direct PLUS funds are credited to student accounts and will be used to resolve outstanding balances. When the transfer of the Federal Direct PLUS monies results in an overpayment of the student's billing account, the excess funds will be refunded in accordance with CASC policy.

Satisfactory Academic Progress: Students must meet certain policies for continuation of federal funds. For more information, please refer to CASC's Satisfactory Academic Progress (SAP) Policy.
